### **Official Rules**

**NO PURCHASE OR CREDIT SCORE IMPROVEMENT NECESSARY TO ENTER OR WIN:**

Open and offered to attendees of Ardent-attended events who are at least 18 years of age on May 23, 2026. Employees, agents and officials of Ardent Credit Union and immediate family members of any of these are not eligible to enter. Void where prohibited. By participating, entrants agree to these Official Rules and the decisions of Ardent. Sweepstake begins at 9:30:00 a.m. EDT on May 23, 2026 and ends at 5:30:00 p.m. EDT on May 23, 2026 (Promotional Period) and is subject to all applicable federal, state and local laws and regulations. **HOW TO ENTER:** There are two (2) ways to enter.

Method #1: Attendees can enter by filling out a form by scanning a QR code with the required fields. No additional action is necessary to participate or enter. One entry per person.

Method #2 (Alternative Method of Entry): Attendees can enter by filling out a paper form with the required fields. No additional action is necessary to participate or enter. One entry per person.

All entries become the sole property of Ardent and will not be returned or acknowledged.

**PRIZE/ODDS:** One entrant will be selected to receive one (1) \$200 Flex CD. The entrant with the guess closest to the actual number of beads in the container, without going over, will win. If more than one entrant guesses the closest number, a winner will be randomly selected from the list of those tied. Odds of winning depend on total number of eligible entries received.
